Why do partnership?

- God is already at work
- God is already at work....
 - Before Philip got to the Ethiopian Eunuch God was already at work with him (Acts 8: 26-40)
 - And before Peter got to Cornelius God was already at work in his household and community (Acts 10)



One body, many parts

- In 1 Corinthians 12 Paul describes the body of Christ as one body with many parts, working together (vs. 12-14)
- There are significant lessons from this passage for effective partnership



One body, many parts

1 Corinthians 12

True Partnership...

- Recognizes that the body of Christ is diverse
- Appreciates that as unique as we may be in our identity we belong to a bigger and diverse family
- Understands that no part has monopoly of what it takes for the body to work effectively [No cultural or geographical context should have monopoly]

One body, many parts

- 1 Corinthians 12
- True Partnership
- Appreciates that each part needs the other, including those that may be perceived as weak or insignificant
- Recognizes that we have as much to learn from other parts of the body as we have to contribute to it
- Understands that God calls us to unity in diversity



- Practice interdependency
- Listen and learn
- All parts are equal; each part plays their role
- Practice giving and receiving from others
- Practice paying attention to the effects of power on communication, decisions, and resources
- Cultivate the practice of being a partner in yourself
- Practice identification with others in their world and realities



Partnership is...

Listening to and learning from all that God is doing globally; identifying with the body of Christ and situations of needs and enrichment in God's world; and working with like-minded people to effectively match resources with needs for maximum Kingdom Impact.



- The *listening* and *learning* process needs to be mutual. In other words, it is not only those in situations of need that must listen and learn.
- Those in well resourced situations also need to listen and learn from those in (or those perceived to be in) situations of need.
- It is in the listening process that we together learn values, community and dependence on God, among other things.



- The process of listening, learning and sharing with one another should impact God's world with compassion, justice, advocacy and other aspects of Kingdom values.
- Those in affluent contexts have much more to listen to and learn from those in supposedly poor contexts of the world.



Suggestions for practicing

- Do some research
- If your project idea is supposed to help a group of people, consider inviting someone from the "target" group
- Spend some time with prospective partners
- Be curious, ask questions, keep a learning posture



Suggestions for practicing

Shared Resources ...

- ...are not just monetary or financial but include:
- Prayer
- Fellowship
- Skills
- Expertise
- Companionship
- As well as the material or financial



Conclusion

This may involve...

- Giving up my affluence, power, privileges (e.g., the privilege of choice.)
- Being open to explore new territories of engagement and involvement in God's purposes
- Identification with others in their world and realities



Conclusion

- Power undermines partnership
- The ultimate goal is to enrich the body of Christ based on the principle of Ephesians 4:16

"From him the whole body, joined and held together by every supporting ligament, grows and builds itself up in love, as each part does its work." (NIV)
